2. Commander's Narrative Summary of Significant Events

a. Battalion Landing Team 3/5 was activated on 1 January 1966 at Camp Pendleton and placed under operational control of Commanding General First Marine Division (Rein)(Rear) on that date. On 12 February the Battalion Landing Team came under the operational control of Commanding General, Fleet Marine Force Pacific. At that time Battalion personnel strength was 27 Officers and 384 enlisted. Manning level was achieved by attachments and inorganic Navy personnel when the Battalion Landing Team activated. Prior to 12 January training, other than General Military Subjects Training, was not possible. The preponderance of available personnel was effectively utilized to maintain equipment, to prepare supplies and equipment for embarkation and to provide all housekeeping personnel to operate Camp Margarita. This effort, at a time when serious personnel shortages existed, allowed training to be emphasized when personnel became available in the future. It also allowed Battalion Landing Team 2/5 and other units of Regimental Landing Team-5 to satisfy their more urgent requirements for training and embarkation preparations. Although it was necessary to de-emphasize training during this initial formative period of serious personnel shortages, it was by no means ignored. General Military Subjects Training was accomplished to the maximum extent possible for all Battalion Landing Team 3/5 personnel when not engaged in the maintenance of equipment, in preparation for embarkation or in maintaining the Camp.

b. Company K was activated on 17 January and commenced training on 24 January. Company L was activated on 24 January and began training one week later. Company M, the last company formed, was activated on 31 January and commenced training on 7 February.

c. Battalion Landing Team 3/5 embarked for a restricted area on 1 March from USNB San Diego and USNS Long Beach. The Battalion Executive Officer, Major ELKINS, remained at Camp Pendleton with a small command group to close camp facilities and to precede the Battalion Landing Team to Okinawa as an advance party.

d. A planned 15-day shipboard training schedule of 4½ hours per day was commenced two days after embarkation and was completed by the end of the voyage. On 9 March the Battalion Landing Team reached USNB Pearl Harbor. Wet net training for all troops aboard the U.S.S. RENVILLE was accomplished. Briefings at Headquarters Fleet Marine Force Pacific for the Battalion staff were held. Battalion Landing Team 3/5 departed from USNB Pearl Harbor for Okinawa.

e. On 26 March, the Battalion Landing Team debarked assigned shipping at White Beach, Buckner Bay, Okinawa. Headquarters 3rd Battalion, 5th Marines was established at Camp Schwab. The Battalion Landing Team was de-activated upon arrival on Okinawa and all attached units returned to their parent organizations. Formal field training for the Third Battalion, Fifth Marines began on 28 March. During the period 28 March through 10 May all units underwent formal training in Counter-Guerrilla Warfare, Landmine/Demolitions/Booby Traps and Jungle Firing Lanes. Training in the field emphasized small unit tactics on the squad and fire team level with accelerated progression towards platoon and company tactics. The last week of training emphasized company level tactics.

f. On 4 April a detachment consisting of Company K, Company I, H&S Company (-), Battery F 2/11 and a detachment from Company B, First Motor Transport Battalion embarked from Naha, Okinawa for two weeks training at Camp Fuji, Japan. Extensive field firing, including training for the newly formed 60mm Mortar sections, was conducted. All units returned to Camp Schwab on 20 April 1966.

g. The Third Battalion, Fifth Marines and attachments of Anti-Tank platoon, Motor Transport platoon, and Tank platoon stood a personnel inspection for BrigGen STILES, Commanding General 9th Marine Amphibious Brigade on 9 April at Camp Schwab. During the following two weeks the Third Battalion, Fifth Marines underwent technical inspections by the 9th Marine Amphibious Brigade Staff.

h. An Regimental Landing Team-5 Command Post Exercise-Field Firing Exercise took place from 20-22 April with the Third Battalion, Fifth Marines (-) participating. Its primary purpose was to exercise the Battalion and attached units in Battalion Landing Team/Special Landing Force operations. Although two rifle companies were absent while en-route from Camp Fuji, valuable training was accomplished. Brigadier General RYAN, newly assigned Commanding General 9th Marine Amphibious Brigade, visited and observed operations in the field;

i. Battalion Landing Team 3/5 was activated for planning on 19 April and for operations on 26 April. By this date, due to accelerated training on Okinawa, Battalion Landing Team 3/5 had reached a high state of combat readiness. Units consisting of a Shore Party Team, Amphibious Tractor platoon, Dental Detachment and Force Service Regiment Detachment reported Operational Control/Administrative Control to Battalion Landing Team 3/5 at 060200Z May. All other units had reported on 26 April. The Third Battalion, Fifth Marines chopped Operational Control/Administrative Control from Regimental Landing Team-5 to the 9th Marine Amphibious Brigade at 060300Z May66.
